OPTION 1. I want the **D. _____** listed above. You may ask to be paid now, but I also want Medicare billed for an official decision on payment, which is sent to me on a Medicare Summary Notice (MSN). I understand that if Medicare doesn't pay, I am responsible for payment, but I can appeal to Medicare by following the directions on the MSN. If Medicare does pay, you will refund any payments I made to you, less co-pays or deductibles.

OPTION 2. I want the **D. PT services** listed above, but I cannot bill Medicare. I will be asked to pay now and I am responsible for payment. I cannot appeal if Medicare is not billed.

OPTION 3. I don't want the **D. _____** listed above. I understand with this choice I am **not** responsible for payment, and I cannot appeal to see if Medicare would pay.

H. Additional Information:

Katherine Braun, PT is no longer registered with the Medicare plan. As such, Medicare Part B will not pay for services. You will not be able to submit to a Secondary Provider linked to Part B either.

However, if your outpatient services are paid by a Commercial Insurance provider, then your PT services are not under Medicare's program. As such, you may have Out-of-Network provider benefits available in your plan to use for some reimbursement. Check with your individual insurance plan.
